ENQUIRES ABOUT RESULTS 2025

Service 1 : Clerical Re-check

A re-check of all clerical procedures. This service **does not** re-mark a script, but simply checks all aspects of administration relating to the script e.g. adding up of marks. Completed within 10 calendar days.

Fees GCSE & GCE – from £9.40 to £14.00 per component dependent on exam board

DEADLINE – 25 September 2025

Priority Service 2 : Review of marking GCE only

This service is only used if a University place depends on it. This urgent application for a review of marking will be dealt with immediately. Marks can go up, down or stay the same. Completed within 15 calendar days

Fees – from £58.00 to £80.25 per component depending on exam board.

DEADLINE – 21 August 2025

Service 2 : Review of marking

This service includes a second examiner reviewing the marking on the script as well as a clerical re-check. Marks can go up, down or stay the same. Completed within 20 calendar days

Fees – from £43.50 to £65.25 per component depending on exam board.

DEADLINE – 25 September 2025

Access to Scripts -Priority Service

This priority service is faster and should **ONLY** be used in order to decide whether or not to apply for a re-mark.

DEADLINE – GCE - 21 August 2025, GCSE - 28 August 2025

Access to Scripts

This service should be used **EXCEPT** when deciding whether or not to apply for a re-mark.

DEADLINE - 25 September 2025
